2024 NATIONAL EUCHARISTIC REVIVAL

If ever our country and our nation needed a renewed understanding and appreciation of Jesus in the Eucharist, it is now. In 2022 the U.S. Conference of Catholic Bishops began a daring initiative to celebrate the presence of Jesus in the Eucharist. These years of renewal will culminate in our National Eucharistic Revival from July 17-21 in Indianapolis, IN.

The real and abiding presence of Jesus in the Eucharist is fundamental to our Catholic faith. Jesus said he would not leave us orphans and indeed, he has not only poured out His Spirit into our hearts but He has chosen to guide and nourish us on our earthly pilgrimage with his own Body and Blood. This is the food He has given us for our journey.

Four pilgrimages have been underway since May 16th from various parts of the country and will converge in Indianapolis on July 16th. By then Jesus in the Eucharist will have been carried on foot in procession over 6000 miles.

To be part of this Eucharistic Revival, at Our Lady of Lourdes, on July 18th, we will begin having Eucharistic Adoration with Exposition of the Blessed Sacrament every Thursday from 9:00 am until 5:00 pm. Please plan to join us in spending some time in the presence of the Son of God truly present in the Blessed Sacrament.

May this Eucharistic Revival bring all of us to a deeper faith that in the celebration of the Eucharist, Christ makes himself present to give us a share in his victory and triumph over death.

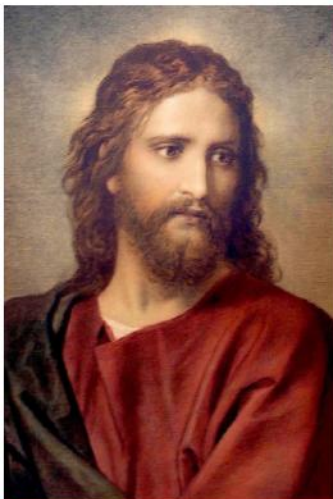

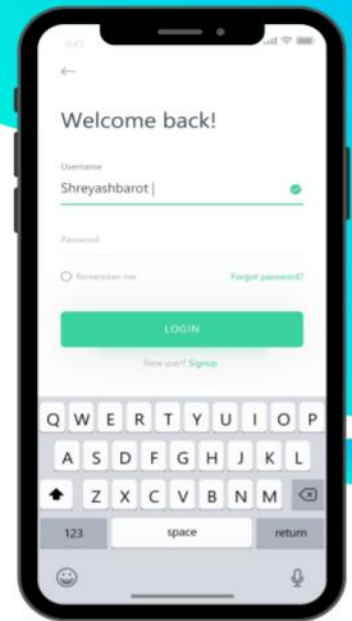
